Welcome to Illinois DECA. DECA prepares emerging leaders and entrepreneurs in Marketing, Finance, Entrepreneurship, Hospitality and Management. This goal can only be reached with the support of all Illinois DECA Advisors and from the administrators at your school.

Expectations for current DECA Advisors include:

General Information & Membership

- Attend Regional Advisor Meetings as scheduled (at least one advisor per school) to which they are members. No students allowed without consent of Area President.
- Check the ildeca.org web site Calendar for upcoming events and deadline dates; Handbook for general information.
- Complete Initial online registration for Membership and send Charter Fee & IFME dues payments by November 30, 2024, to Mark. (***Initial State Membership, Charter and IFME info/monies not received by November 30, 2024 will result in a \$100 chapter penalty and blockage from ALL IL DECA activities.***)

Illinois Career Development Conference (IL CDC)

- Attending Advisors and Chaperones will be required to assist with events or / assist in other duties as assigned (i.e. walking halls, chaperoning social events, security, possibly judging events). Advisors who refuse to assist when asked may jeopardize their chapter attending IL CDC the following year.
- As in the past 40+ years, everyone in attendance must stay at the designated conference hotel in order to meet our hotel commitment and for safety.
- Report to the Security Advisor both nights after checking your student rooms at IL CDC.
- Turn in your Hotel Room Check card at the Hotel Front Desk prior to leaving on Saturday following the Grand Awards ceremony at IL CDC.

International Career Development Conference (ICDC)

- Advisors attending ICDC will be required to assist with events and Chaperones may be required to assist with events as assigned by DECA Inc.
- Attend Opening & Closing Sessions, staying to the end of the session, at both IL CDC and ICDC sitting with the Illinois Delegation at ICDC.
- Turn in your Hotel Room Check card at the Hotel Front Desk prior to leaving at the end of the conference.

Failure to meet any of the Illinois DECA Advisor Expectations may result in your chapter’s exclusion from future DECA events including the Competitive Events.

Please make sure you are aware of Advisor Expectations and share these expectations with your school administration. It is important that your school principal (or designee) read these expectations and sign below acknowledging the necessary commitment by your school’s DECA Advisor(s).
